## Wyoming Water Well Association Convention!

The Wyoming Water Well Association held the annual convention in Casper January 20 - 22, 2016. The attendance was great and the classes offered were very informative.

The State Engineer's Office representative gave a presentation on upcoming rule changes.

According to George Moser the inability to install custom perforations in a Type II or Type III well may be lifted but a sand content rule is being considered. Moser also discussed changes in the forms for the U.W 6 Statement of Completion and the U.W. 8 Beneficial Use forms.

The proposed rules are not currently out for public comment but notification of the 45-day comment period will be published in this monthly newsletter.

## U.W 6 Statement of Completion! & U.W. 8 Beneficial Use Form!

The Water Well Contractors Board requires that drillers fill out and submit the U.W. 6, Statement of Completion. W. S. § 41-3-935 states that "any person constructing any well under a permit shall, within thirty (30) days after completion or abandonment of such work, report to the state engineer the data required relating to such well, on forms furnished by the state engineer....".

If you are not installing the pump, leave that section of

the form blank and send it to the State Engineer's Office.

It is important to get the U.W 6 form to the State Engineer's Office in a timely manner so it can be reviewed and attached to the permit for the water right adjudication process.

The pump information is now being captured on a revised U.W 8 Beneficial Use Form.

There have been situations when the U.W. 8

Beneficial Use Form, with the pump information is received by the State Engineer's Office prior to the Statement of Completion form. This is problematic since the construction has not been reviewed by technical staff.

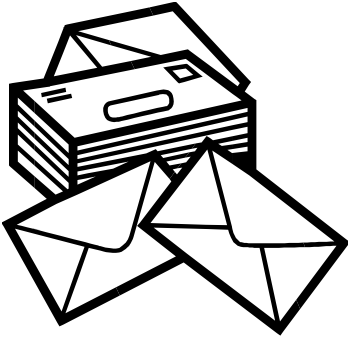
